 - (a) Council will address any consultations received by the Chairman and agree responses accordingly. An application in respect of the Timberdine Barns has been received and Members will be asked to take into account that the Bat Survey carried out in 2005 may be considered to be out of date.
- (6) **Accounts, Financial Matters and Administration:**
 - (a) To consider payment of accounts as presented and displayed at the meeting.
 - (b) To consider two grant applications. One from the Pre School Group and one from the Baptist Church Parent and Toddler Group, both of which provide valuable service to St Peter's residents.
Following this, Council will be asked to consider a new policy in respect of the award of grants from the Parish Council to local and national organisations.
 - (c) Any urgent correspondence and administrative items, including a Newslink update, will be presented by the Clerk.
 - (d) A debriefing of the training given at St Peters Village Hall on January 14th 2008 will be led by the Chairman.
 - (e) To receive update on the current progress with the Multi Use Games Area .
- (7) Members will be updated on the serious problems caused by continual flooding in and around Lobelia Close and will be asked to consider what action, if any, the Parish Council should take.
