 - (a) To consider grants in respect of St Peter's Festival and a new local football team.
 - (b) Council will be asked to consider the latest position regarding the proposed Play Builder grant aided scheme for Trefoil Close.
 - (c) To receive an update in respect of Newslink and to confirm an increase in the delivery charges of £75 per issue.
 - (d) To consider payment of accounts as presented and displayed at the meeting.
- (8) **Delegated Decision:** During the summer recess, delegated Cllrs agreed to provide a £672 grant to the Village Hall Committee to fund a trial six week security patrol of the Multi Use Games Area, as well as locking the gates nightly. Subsequently this Council has been asked to provide and pay for the service instead of a giving a grant. Council are now asked to make a formal decision to endorse, accept and fund the contract already in place from an appropriate budget head.
