These proposals will be presented to a future council meeting for decision. The proposals will be without prejudice or commitment until such time as the council has made a decision to adopt them.

- (a) To consider authorising the purchase of eighteen trees/shrubs to replace losses within Power Park from the original suppliers at an advantageous discounted rate of £188.80 plus a contingency sum for delivery of £50.
- (b) To consider payment of accounts received and presented to Council at the meeting.
- (c) Council's approval is sought for the replacement of a damaged litter bin. The Warden recommendation is the Glasdon Jubilee at a cost of £350.30 +vat. If approval is given then consideration will be given by the Clerk to making an insurance claim.
