

St Peter the Great County Parish Council

Minutes of a meeting of the Parish Council held on Monday 30th July 2007 at 7.45pm in the Village Hall, St Peters.

Present: Chairman, Cllr. R. MacFarlane; Cllrs. Mrs. J. Chown, Mrs S. Winter, R. Knight, R. Fowler, P. Thorlby, CSO. J. Atkins.

Mr. D. Wareing, Chief Executive, Worcester City, kindly attended the meeting and briefly addressed Council in respect of the excellent partnership between St Peter's Parish Council and the City Council. He highlighted the success of the Crime and Disorder Strategy, evident in the very low crime figures for the St Peter's estate and praised the work of the Detached Youth Team active within the area. He also emphasised the value of participation in the Worcester Alliance and the obvious benefits of the consultation processes afforded to the Parish Council, touching briefly on the future, including the prospect of unitary authorities. A number of questions concerning local issues were raised by Members, which were noted by Mr Wareing for consideration by the City Council. The Chairman thanked Mr Wareing for his valuable input and co-operation, and asked that the City Council staff be made aware of the Parish Council's sincere appreciation for their continual friendly support. Mr Wareing was invited to remain for the rest of the meeting.

5507 Apologies for Absence: Cllr. Rev. D. Ballard, County Councillor Cairns and City Councillor Tarbuck were unable to attend because of other commitments.

5607 Declarations of Interest: There were no declarations.

5707 Co-option of Councillor: Cllr. R. Knight nominated Mr. G. A. Lawrence of 6 Broomhall Green for co-option to fill one of the two existing casual vacancies. This nomination was seconded by the Chairman. The Clerk confirmed that the nominee was fully qualified to serve. Members unanimously resolved to co-opt Mr Lawrence and having signed the declaration of acceptance of office, took his place at the table.

5807 Adoption of Minutes: Council unanimously agreed adoption and signing of the minutes of the meeting of the Parish Council held on Monday 25th June 2007 and of the Extra-Ordinary Parish Council Meeting held on the 5th July 2007.
