

# St Peter the Great County Parish Council

Minutes of a meeting of the Parish Council held on Monday 22<sup>nd</sup> February 2010 at 7.45 pm in the Village Hall, St Peters.

**1010 Declarations of Interest:** There were no declarations. The Clerk reminded Members to renew their declared interests document to the Monitoring Officer, via the Clerk who can provide a form if necessary.

**1110 Adoption of Minutes:** The minutes of the meeting of the Parish Council held on Monday 25<sup>th</sup> January 2010 were adopted and signed.

**1210 Short Information Reports:**

- (a) Council received a brief verbal report from CSO. T. Harris, confirming that there were no incidents of crime during the period since the last meeting. A few minor items of information were noted.
- (b) Council formally received a written report from the St Peter's Warden and raised a number of questions with him.
- (c) The Chairman reported on a recent Working Group meeting. No decisions were required. He paid tribute to the team for producing the latest first class issue of Newslink. The next absolute deadline for the next issue to be midnight March 25<sup>th</sup> 2910.
- (d) Members received a short report from CSO. T. Harris, in respect of the last PACT meeting. Many of the items raised at the meeting were those raised by members of the public at the previous Parish Council meeting and were now being addressed.
