1810 Declarations of Interest: The Chairman, Cllr McFarlane, declared a non crucial interest in the Playbuilder item in respect of his property being adjacent to the proposed location of equipment.

1910 Adoption of Minutes: The minutes of the meeting of the Parish Council held on 22nd February 2010 were adopted and signed.

2010 Short Information Reports:

- (a) CSO L, Rowbotham gave a brief update, confirming that St Peters continues to be generally crime free except for two instances of anti social behaviour which were being dealt with. .

- (b) Cllr. Knight gave an update in respect of the Village Hall, confirming that representatives of the Hall management committee had arranged a meeting to enable consultation with Community First in April and that a modular building might be considered.
