

# St Peter the Great County Parish Council

Minutes of a meeting of the Parish Council held on Monday 26<sup>th</sup> July 2010 at 7.45 pm in the Village Hall, St Peters.

**2710 Declarations of Interest:** There were no declarations.

**2810 Adoption of Minutes:** The minutes of the Meeting of the Parish Council held on Monday 21<sup>st</sup> June 2010 were adopted and signed.

**2910 adjournment:** At this point the Chairman adjourned the meeting to permit three young members of the public to make a representation regarding funding for local football facilities at St Peters. Members recognized their needs and the Chairman advised them of the procedure for requesting a grant from the Parish Council, to which Council would give consideration. The Chairman thanked them for attending.

**3010 Short Information Reports:**

Council received a written report from Parks and Cemeteries in respect of the work of the Warden and Lengthsman for the July period.

**3110 Planning Matters:**

No objections were raised in respect of a single planning consultation.

**3210 Administration:**

- (a) The Clerk informed Councillors of all correspondence and administrative matters requiring attention.
- (b) It was agreed that a working party meeting would be held on 4<sup>th</sup> October 2010 at 8pm in the Village Hall, St Peters, to consider recommendations in respect of the Annual Review.

- (b) The Chairman brought Council up to date in respect of the St Peters Festival and explained the application process by which Council would consider grant-aid to the applicant groups. The Chairman also outlined the Village Hall Festival agreed participation in respect of a ‘tournament within the Multi Use Games Area and other events in the Hall’. - (c) Council were advised of the latest position regarding the proposed Play Play Builder grant aided scheme on Power Park at Trefoil Close.
- (d) Council received an update in respect of the current issue of Newslink and considered a request from the distribution contractor for an increase in the delivery charges of an additional £100 per issue. Council agreed the justification for an increase of up to £100 because of the increased weight of the magazines and the fact that no price increase had been made in the previous three years, during which time there had been a increase in the number of properties served.. The Clerk was authorised to agree an increase with the contractor up to the agreed £100.
